Pursuant to the Notice of Filing and Comment Period issued on February 25, 2026, in the above-referenced docket, Questar Gas Company dba Enbridge Gas Utah (“Enbridge Gas,” “EGU,” or “Company”) respectfully submits these Reply Comments in response to the Utah Division of Public Utilities (“Division”) comments to the Verified Application seeking approval for an adjustment to the Utah Carrying Charge, filed on March 9, 2026. On February 23, 2026, the Company filed a Verified Application with the Public Service Commission of Utah (“Commission”) requesting approval to adjust the Utah Carrying Charge.

The Company has reviewed the Division’s comments. The Division references Utah Natural Gas Tariff 600; however, the current effective tariff is Tariff 800. Therefore, when the Division recommends the Commission approve EGU’s revised Schedule 600, it should instead state the Division recommends the Commission approve EGU’s Tariff 800, Section 8.07.

Other than those references, the Company agrees with the conclusions contained therein. Enbridge Gas Utah appreciates the Division's diligent and thorough review of the Application and acknowledges the Division's efforts to ensure that the rates and associated calculations are just, reasonable, and in the public interest.
