On March 1, 2005 , the Commission conducted a scheduling conference at which Questar Gas Company (Questar), the Utah Division of Public Utilities (Division), the Committee of Consumer Services (Committee), intervenors and interested persons discussed scheduling issues in the above dockets and determined filing and hearing dates for Commission consideration of the issues.

October 28, 2005	Surrebuttal to testimony filed on October 17

A hearing on this matter is scheduled to commence on Tuesday, November 1, 2005, at 9:00 a.m., in the Commission's main hearing room, at 160 East 300 South, Heber M. Wells Building, 4<sup>th</sup> Floor, Salt Lake City , Utah . As necessary, hearings will continue on November 2, 3 and 4, to begin at 9:00 a.m.

Public witness testimony will be received on Wednesday, November 2, 2005, commencing at 4:30 p.m. , in the Commission's main hearing room.
