
The Division of Public Utilities (Division) respectfully requests the Commission to extend the schedule for the remaining items on the Scheduling Order in this matter. The Division requires more time to prepare its initial draft proposed rule for circulation to the parties, and thus seeks an extension of the circulation date by one week. The Division believes that it is also appropriate to extend the other dates by one week to allow the parties adequate time to respond and participate. The Division is authorized to represent that PacifiCorp and Qwest will stipulate to the one week extension of the dates.

Accordingly, the Division proposes the following revised schedule in this docket:

June 4, 2004	DPU to circulate its draft proposed rule
June 21, 2004	Parties to provide comments on DPU's draft
July 14, 2004	Revised proposal from the DPU based on the comments of the Parties
July 16, 2004	Technical conference in Salt Lake City

Following these dates the DPU will determine what additional steps will be necessary, if any, before submitting its proposed rule to the Commission.


