1. Increase the limit of grid tied system from 0.1% to the level allowed in surrounding states (2 to 5%).
2. Increase the solar incentive program by Rocky Mountain Power (RMP) which currently limits it to 57 residential units per year and a dollar amount of less than \$1 million, to at least 600 residences and \$10 million per year. This money could come from the \$36 million rate increase the PSC approved for RMP already or included in any additional increases in rates demanded by RMP to meet increasing demands for electricity.
3. Increase the metering reimbursement rate for renewable energy to at least that currently charged for the "blue sky" program (i.e. 9.5 cents per kWh or 12 cents as in California)
