By The Commission:

On May 3, 2009, the Utah Public Service Commission held a scheduling conference to establish a schedule for public comments and participation concerning the implementation of certain provisions of Senate Bill 75, passed in the 2009 Legislative Session of the Utah Legislature. A copy of the text of the bill may be reviewed at <http://le.utah.gov/~2009/bills/sbillenr/sb0075.htm> The comments and participation sought from interested individuals are to assist the Commission in preparing to undertake the rulemaking required by Utah Code §54-7-12(1)(b)(ii) [directing rulemaking concerning the minimum requirements to be met for a rate case application to be considered a “complete” filing] and §54-7-13(1)(a)(ii) [directing rulemaking concerning the minimum requirements to be met for a major plant addition application to be considered a “complete” filing].

Pursuant to the Scheduling Conference discussion, the Commission sets the following schedule for pre-rulemaking activities prior to following the Utah Administrative RuleMaking Act, Utah Code §§63G-3-101, et seq., to enact a new or amend existing rule provisions to comply with the statutory directives:

- May 18, 2009 Interested individuals shall file with the Commission, and serve upon individuals on the email list, written comments and suggestions of rule provisions which they believe would direct or provide guidance on what constitutes a “complete” filing in compliance with Utah Code §54-7-12(1)(b)(ii) and §54-7-13(1)(a)(ii).
- May 28, 2009 The Commission will make available to the public and distribute to participants in this docket a preliminary draft of rule provisions for comment.
- June 11, 2009 Interested individuals shall file with the Commission, and serve upon individuals on the email list, written comments on the May 28 preliminary rule draft.
- June 23, 2009 A public meeting will be held, beginning 8:30 a.m., in Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. The purpose of the meeting will be to review the May 28 preliminary rule draft, the June 11 comments, and determine which preliminary rule provisions need no modification and those which should continue to be considered by the Commission before final rulemaking.
- July 2, 2009 The Commission will make available to the public and distribute to participants in this docket a revised draft of rule provisions based

on its further consideration and the information provided at the June 23, 2009, meeting.

A public meeting will be held, beginning 8:30 a.m., in Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. The purpose of the meeting will be to review the July 2 revised rule provisions and allow interested individuals to provide comments which they believe should be considered by the Commission before final rulemaking.
