



AFFIDAVIT OF WESLY MINELLA


I, Wesly Minella, having been duly sworn make this affidavit based upon my person knowledge and state as follows:

- 1) I am Secretary of Cordia Communications Corp. ("CCC") and duly authorized to file this affidavit on MTC's behalf.
- 2) CCC filed for a voluntary petition under Chapter 11 of the US Bankruptcy Code on May 1, 2011 in the Middle District of Florida, Case 6:11-bk-06493.
- 3) On July 14, 2011, the bankruptcy court approved an Asset Purchase Agreement between Birch Communications Inc. ("Birch") and CCC that provides for the sale of certain assets and customers of CCC located in jurisdictions where CCC is licensed to operate as a wireline telecommunications service provider. CCC's customers located in Utah were not included in the aforementioned asset purchase.
- 4) CCC's legal counsel filed an application to discontinue services to customers located in Utah effective October 13, 2011.
- 5) CCC sent a Notice of Discontinuance of Telecommunications Services to its customer base located in Utah on or about September 9, 2011, giving its customers adequate notice of the abandonment of service.
- 6) CCC will promptly execute change orders received from its end-users to ensure that they are migrated to another carrier without an interruption in service.

**NOTICE OF DISCONTINUANCE OF
TELECOMMUNICATIONS SERVICES**

On May 1, 2011, Cordia Communications Corp. ("Cordia") filed under Chapter 11 of the United States Bankruptcy Code in the Middle District of Florida, Case Number 6:11-bk-06493. On July 14, 2011, the bankruptcy court approved an Asset Purchase Agreement between Birch Communications Inc. ("Birch") and Cordia that provides for the sale of certain assets and customers of Cordia.

The Asset Purchase Agreement does not include customers located in Idaho and Utah.
