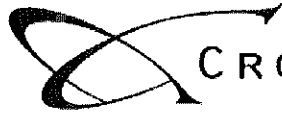

Dear Ms. Orchard:

We are the attorneys for Billing Services of America, Inc.; a reseller of interexchange telecommunications services ("Services"). We hereby serve notice upon the State of Utah Department of Commerce, Division of Public Utilities ("Division of Public Utilities") that Billing Services of America, Inc. intends to provide Services to customers within the State of Utah. It is our understanding that resellers are exempt from the Division of Public Utilities' regulation pursuant to Chapter 2, Section 54-2-1(25) of the Utah Public Utilities Laws, by definition. We further understand that this exemption will not relieve Billing Services of America, Inc. from contributing to Utah's Universal Service Fund ("USF"), (currently .34% of billed intrastate retail rates which can be passed through to end users) unless USF payments are made on the reseller's behalf by the underlying carrier.

Notwithstanding the foregoing, we shall take no further action relative to obtaining authority on behalf of Billing Services of America, Inc. to provide services in the State of Utah. Should the Division of Public Utilities' policy of forbearance with respect to resellers change, please advise.
