Pursuant to Commitment U3(2), incorporated in the Public Service Commission of Utah's *Report and Order* approving the *Acquisition of PacifiCorp by MidAmerican Energy Holdings Company*, issued January 27, 2006, as amended March 14, 2006, and June 5, 2006, Rocky Mountain Power hereby provides notice of an affiliate interest transaction. Filed concurrently as Attachment A is the License for Electric Supply Line Across or Along Railway Property (License) between PacifiCorp, and BNSF Railway Company (BNSF), Tracking No. 12-44648.

PacifiCorp is a wholly-owned indirect subsidiary of MidAmerican Energy Holdings Company (MEHC). MEHC is a subsidiary of Berkshire Hathaway, Inc. BNSF is also a subsidiary of Berkshire Hathaway, Inc. Therefore, Berkshire Hathaway, Inc.'s ownership interest in MEHC and BNSF may create an affiliated interest in some PacifiCorp jurisdictions.

The Oregon Department of Corrections is constructing a prison near a portion of the Company's Harrisburg – Lancaster transmission line in Lane County, Oregon. The construction of the prison has required an expansion of a road near the transmission line. The expansion of the road will require the transmission line to be relocated. BNSF owns property in the area for its railroad tracks. Relocation of the Company's transmission line will require a new license with BNSF to allow for the use of BNSF property for housing the transmission facilities. Approximately 107 feet of the transmission line will cross BNSF's property.

BNSF will charge \$3,000 for the License, \$600 for the application fee, and \$400 for insurance fees. Because the relocation of the transmission line is being caused by the Oregon Department of Correction's construction project, the Oregon Department of Corrections will pay the fees from BNSF. The Company will not pay any fees to BNSF for the License.

Obtaining the License is in the public interest because it allows the Company to install and maintain facilities necessary to provide electric service and to meet its obligation to provide safe and reliable electric service. Not having the License would mean that PacifiCorp would not be able to meet its obligation to provide electric service. As the property owner, BNSF is the only entity that can provide this License to the Company.
