It has come to the attention of the Commission that there is an error in the recent Report and Order On PacifiCorp's 2012 Fossil Fuel Heat Rate Improvement Plan ("Order") sent by the Commission on July 16, 2012. On page three of the Order, on the fourteenth line it reads, "Gen Name Plate Ratings-MW)." However, the cost per kWh [sic] in the upper". It should read, "Gen Name Plate Ratings-MW)." However, the cost per **kWh in the upper**". There is also an error on the sixth line of the fourth page under DISCUSSION AND CONCLUSIONS. It reads, "address them in future versions of the plan. On a going forward basis the Company should to". It should read, "address them in future versions of the plan. On a going forward basis the Company **should**". There is an additional error on the fifth page of the Order, in the fourth line under ORDER. It reads, "The Company shall convene a meeting with interested parties no less than 4". It should read, "The Company shall convene a meeting with interested parties no less **than four**".
