On June 21, 2012, the Office of Consumer Services (“Office”) filed a response to the Division of Public Utilities’ (“Division”) Request for Agency Action in this docket, challenging, in part, the statutory authority for the Division’s request. See Utah Office of Consumer Services’ Response to Division of Public Utilities Request for Agency Action, filed July 21, 2012. The Office requests, in part, that the technical conference scheduled for July 19, 2012, be replaced with a scheduling conference. See id. at 7. On July 5, 2012, the Division filed a notice of withdrawal of its request for agency action and did not take a position on the legal or factual claims set forth in the Office’s response.
