Pursuant to the requirements of 47 C.F.R § 54.314, the **Public Service Commission of Utah** hereby certifies to the Federal Communications Commission (FCC) and the Universal Service Administrative Company (USAC) that the eligible telecommunications carriers (ETCs) listed below are eligible to receive federal high-cost support for the program years cited. The **Public Service Commission of Utah** certifies that for the carriers listed all federal high-cost support provided to such carriers within **UTAH** was used in the preceding calendar year (**2014**) and will be used in the coming calendar year (**2016**) only for the provision, maintenance, and upgrading of facilities and services for which the support is intended.¹

High-cost support shall only be provided to the extent that the State has filed the requisite certification pursuant to this section.")
