**DISTRIBUTION ELECTRICAL COOPERATIVE RECOMMENDED FILING INFORMATION FOR NOTIFICATION  
TO THE PSC OF UTAH (PSC)**

**Rate Increase Notification Requirements**

Please include the following information in the filing:

- A statement that the cooperative's board of directors and any appropriate agency of the federal government have approved the rate increase.
- A statement that before implementing any rate increases, the cooperative has held a public meeting for all its customers and members.
- A statement that the cooperative mailed a notice of the public meeting to all its customers and members not less than 10 days prior to date the public meeting was held.
- Revised tariff sheets reflecting the rate increase, which will be made available for public inspection by the PSC.

**Rate Decrease Notification Requirements**

Please include the following information in the filing:

- A statement that the cooperative's board of directors and any appropriate agency of the federal government have approved the decrease.
- Revised tariff sheets reflecting the rate decrease, which will be made available for public inspection by the PSC.

**Tariff Changes not Requiring a Rate Change**

Please include the following information in the form of an advice letter:

- Tariff sheet numbers and titles of the tariff sheets being filed, together with the sheet numbers of the sheets being canceled;  
information as to the reason for the filing;  
dates on which the tariff sheets are proposed to become effective;  
identification of tariff conditions that are more or less restrictive, or withdrawn.  
**(Note: the effective date of any proposed tariff change not requiring a rate change shall not be less than 30 calendar days after the date of the filing, unless otherwise approved by the PSC.)**
- If the filing covers a new service not previously offered or rendered, an explanation of the general effect of the filing, including a statement as to whether present rates or charges will be affected, or service withdrawn from a previous user and advice whether the proposed rates are cost-based.
- A statement that the proposed tariff sheets do not constitute a violation of state law or PSC rule.
- Revised tariff sheets reflecting the proposed changes, in clean and red-lined versions.
