(“Bear Lake”), and Skyline Telecom (“Skyline”), hereby moves the Public Service Commission for permission to deviate from the electronic filing requirement set forth in Utah Admin. Code. R746-1-203 for the submission of the *Confidential* CAF ICC Data for CUTI, Bear Lake, and Skyline (the “Confidential CAF ICC Data”) in the above referenced docket. Kira M.
