ISSUED: June 5, 2017

On June 5, 2017, Central Utah Telephone, Inc.; Bear Lake Communications, Inc.; and Skyline Telecom filed this joint motion to deviate from Utah Admin. Code R746-1-203, which sets forth an electronic filing requirement. In filing this motion, the utilities represent that they are in the process of implementing technology that will allow them to comply with the electronic filing requirement, but cannot complete the process by the June 7, 2017 deadline applicable to this docket. Therefore, the utilities attest that the rule imposes a hardship that outweighs its benefits. Utah Admin. Code R746-1-109(2).

Given the foregoing, the Public Service Commission of Utah grants the motion to deviate and permits Central Utah Telephone, Inc.; Bear Lake Communications, Inc.; and Skyline Telecom to submit disc(s) in order to provide confidential information relative to the July 7, 2017 filing deadline.
