Notice of Termination

Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act, 16 U.S.C. § 824d (2012), Part 35 of the Federal Energy Regulatory Commission’s (“FERC” or the “Commission”) regulations, 18 C.F.R. Part 35 (2018), and Order No. 714<sup>1</sup> regarding electronic filing of tariff submittals, PacifiCorp hereby notifies the Commission that it is terminating PacifiCorp Service Agreement No. 917 under PacifiCorp’s Volume No. 11 Open Access Transmission Tariff (“OATT”), a Project Construction Agreement for the Sigurd Solar TSR Project (“Construction Agreement”) between PacifiCorp Transmission (“PacifiCorp”) and PacifiCorp Energy Supply Management (“ESM,” together with PacifiCorp, the “Parties”). PacifiCorp respectfully requests an effective date for this termination of July 30, 2019, for the reasons described below.

## **1. Background and Reason for Filing**

On December 20, 2018, ESM and PacifiCorp entered into the Construction Agreement. The Construction Agreement sets forth the terms and conditions under which PacifiCorp agreed to perform and ESM agreed to pay for work to accommodate ESM’s request for network transmission service for an underlying generation interconnection project. PacifiCorp filed the Construction Agreement with the Commission on December 31, 2018 in Docket No. ER19-749-001. On February 22, 2019 the Parties amended the Construction Agreement for clarity. On February 25, 2019, PacifiCorp filed the amended and restated Construction Agreement with the Commission. On March 22, 2019, the Commission accepted the amended and restated Construction Agreement for filing via letter order, deemed the Construction Agreement effective on December 20, 2018, and designated the Construction Agreement as PacifiCorp Service Agreement No. 917.<sup>2</sup>

It has been determined that the work required by the Construction Agreement is duplicative of certain work required pursuant to a Standard Large Generator Interconnection Agreement between Sigurd Solar, LLC and PacifiCorp, dated July 31, 2018, as amended on April 5, 2019, designated as PacifiCorp Service Agreement No. 897, Revision 1. Accordingly,

the Parties have agreed that the Construction Agreement should be terminated, and PacifiCorp now seeks to terminate the Construction Agreement.

## **2. Effective Date**

In accordance with 18 C.F.R. § 35.15(a) of the Commission's regulations, PacifiCorp respectfully requests that this termination become effective July 30, 2019, which is 61 days from the date of this filing.

PacifiCorp has provided notice of this filing to the lone affected party, ESM.
