On May 3, 2023, the Public Service Commission (PSC) issued an action request to the Division of Public Utilities (DPU), with a due date of June 2, 2023, requesting a report from the DPU on the electric cooperative companies' compliance with Utah Admin. Code R746–312–16 (the "Electrical Interconnection Rule") and R746–313–7 (the "Electrical Service Reliability Rule") (collectively, the "Rules"). Subsequently, the DPU requested and was granted an extension of time to respond to the action request. On July 25, 2023, the DPU filed its action request response recommending the PSC schedule a technical conference to afford the electric cooperative companies an opportunity to discuss and clarify their positions on the Rules. On August 30, 2023, the Utah Rural Electric Cooperative Association submitted correspondence to the PSC, indicating its support for a technical conference and providing three suggested dates.

Good cause appearing, the PSC gives notice a technical conference will be held in this docket on Monday, September 25, 2023, beginning at 1:00 p.m., Fourth Floor Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.
