Dear MR. LEVAR:

Kern River Gas Transmission Company (Kern River) owns and operates an interstate natural gas pipeline system that provides natural gas transportation in Wyoming, Utah, Nevada and California. Kern River's interstate natural gas pipeline system includes approximately 1,700 miles of pipeline.

Kern River is proposing to construct the Delta Lateral Project, which will provide natural gas from Kern River's two existing 36-inch-diameter mainlines near Holden, Utah, to the Intermountain Power Project (IPP), a power plant near Delta, Utah. IPP is developing new energy generating capacity. The Delta Lateral Project's facilities, which will be located in Millard County, Utah, include an approximately 35-mile, 24-inch-diameter natural gas pipeline, tap assemblies, in-line inspection device launchers/receivers, automated mainline valve assembly and a meter station. The Project will enable Kern River to meet the energy needs of its customer.

To further introduce landowners and other stakeholders to the project, Kern River is hosting two open houses near the project area. You are welcome and encouraged to attend either or both of the open houses listed below. Subject-matter experts will be at the locations to address landowner, environmental, safety and any other concerns you may have. While there will be no formal presentation at these open houses, Kern River will have information available on the scope of the project including the planned pipeline route. The open houses will be an opportunity for Kern River to listen to landowners and address stakeholder concerns. The information at each open house will be similar, and you are free to attend the open house(s) that is most convenient for you. The following open houses have been scheduled.

Due to COVID-19, we will be practicing physical distancing at the open houses. If you choose to attend, we also request that you wear a mask inside the meeting venues.

Kern River has received approval from the Federal Energy Regulatory Commission (FERC) to utilize FERC's pre-filing process. FERC approves the location, construction and operation of interstate natural gas pipelines and related facilities and conducts an environmental review of the project to ensure impacts are

minimized. The pre-filing process was established to allow project applicants, such as Kern River, to work proactively with affected and interested stakeholders prior to filing the required application with FERC. The pre-filing process includes the implementation of a Public Participation Plan. Kern River's pre-filing approvals and subsequent documents are docketed at FERC at Docket No. PF20-4. The docket may be accessed through the FERC website at www.ferc.gov. Kern River plans to file its application with FERC requesting authorization to construct the facilities in March 2021. If FERC approves the application, construction for these facilities is scheduled to begin in spring 2023.
