#### SECTION 63.71 APPLICATION OF MCI COMMUNICATIONS SERVICES LLC; MCIMETRO ACCESS TRANSMISSION SERVICES OF VIRGINIA, INC.; MCIMETRO ACCESS TRANSMISSION SERVICES CORP.; AND VERIZON LONG DISTANCE LLC

MCI Communications Services LLC; MCImetro Access Transmission Services of

Virginia, Inc.; MCImetro Access Transmission Services Corp. (collectively, "the MCI Entities");

and Verizon Long Distance LLC ("Verizon Long Distance") submit this Application for authority

under Section 214(a) of the Communications Act and Section 63.71 of the Commission's rules to

grandfather and discontinue certain Metro Private Line Access and U.S. Private Line services

offered by the MCI Entities and to discontinue certain National Private Line services offered by

Verizon Long Distance, as specified below.

Subject to Commission authorization, we plan to stop offering to new customers and then

eventually discontinue these services as specified below.<sup>1</sup> There are no residential or consumer

customers who subscribe to these services, and the services are not plain old telephone service

("POTS").

Consistent with Section 63.71(a) and (c) of the Commission's rules, the MCI Entities and

Verizon Long Distance provide the following information:

## 1. Name and Address of Carrier (47 C.F.R. §§ 63.71 (a)(1), (c)(2)):

#### 2. Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (c)(2)):

Subject to the Commission's authorization, on or after June 30, 2021, the MCI Entities

will cease offering the specified Metro Private Line Access and U.S. Private Line services to new

customers (the services will be "grandfathered" as defined in 47 C.F.R. § 63.60(d)).

Subject to the Commission's authorization, on or after June 30, 2021, the MCI Entities

also will not permit existing customers of the specified Metro Private Line Access and U.S.

Private Line services to make moves, additions, or changes ("MACs") in most cases. MACs will

be allowed if any of the following conditions (the "MACs-allowed conditions") applies:

- A circuit originates or terminates in any of the following areas: Connecticut, Delaware, the District of Columbia, Maryland, Massachusetts, New Jersey, New York, Pennsylvania, Rhode Island, and Virginia (collectively, the "Exception Areas").
- Any services that are provisioned with a telecommunications service priority ("TSP") designation as of June 30, 2021.

- Services that are:
  - Metro Private Line End Link Point-to-Multipoint Digital Data (DS0) Full Bandwidth provisioned to an existing Metro Private Line Point-to-Multipoint High Capacity (DS1) Hub Arrangement;
  - Metro Private Line End Link Point-to-Multipoint High Capacity (DS1)
     Full Bandwidth provisioned to an existing Metro Private Line
     Point-to-Multipoint Very High Capacity (DS3) Hub Arrangement; or
  - Metro Private Line Point-to-Point High Capacity (DS1) Full Bandwidth provisioned to an existing Metro Private Line Point-to-Point Very High Capacity (DS3) Channelized circuit.

Subject to the Commission's authorization, on or after March 31, 2022, the MCI Entities will discontinue the specified Metro Private Line Access and U.S. Private Line services in the geographic areas identified in Section 3 below, and Verizon Long Distance will discontinue the specified National Private Line services in the geographic areas identified in Section 3 below.

## 3. Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), (c)(2)):

Subject to the Commission's authorization and as stipulated by this application, on or after the dates identified in Section 2, the MCI Entities will cease offering new customers the specified Metro Private Line Access services in all 50 states and the District of Columbia, and will cease offering new customers the specified U.S. Private Line services in the contiguous United States and the District of Columbia. On or after the date listed in Section 2, the MCI Entities will discontinue these services in the same respective areas except for circuits that originate or terminate in any of the Exception Areas.

Subject to the Commission's authorization, Verizon Long Distance will discontinue the specified National Private Line services in Alabama, Arizona, Arkansas, California, Colorado, Connecticut, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Michigan, Minnesota, Mississippi, Missouri, Nebraska, Nevada, New Hampshire, New Mexico, New York, North Carolina, Ohio, Oklahoma, Oregon, South Carolina, Tennessee, Texas, Utah, Virginia, Washington, and Wisconsin.

# 4. Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(4), (c)(2)):

The MCI Entities seek to cease offering to new customers and discontinue certain Metro Private Line Access and U.S. Private Line services. These are not "plain old telephone service" or POTS services.

Alternative Services and Products: Customers today can obtain alternative services and products from Verizon or other providers that may suit customers' needs depending on the customers' particular applications. Possible alternative products and services include: Private IP, Ethernet Dedicated E-Line, Ethernet Switched E-Line, and Internet Dedicated Ethernet services. Verizon will work with affected customers to find suitable alternative solutions.

#### a. MCI Metro Private Line Access Services

Metro Private Line Access services are interstate services that provide point-to-point, point-to-multipoint, and multipoint services between IntraLATA or designated corridor locations. These services provide the customer dedicated access to private telecommunications networks, wide area networks, and connections with information service providers and interexchange carriers that transport interstate traffic. The following Metro Private Line Access Services are covered by this Application:

- Point-to-Point Voice Grade—Full Bandwidth;
- Point-to-Point Digital Data (DS0)—Full Bandwidth;
- Point-to-Point High Capacity (DS1)—Full Bandwidth;
- Point-to-Point High Capacity (DS1)—Channelized;
- Point-to-Point Very High Capacity (DS3)—Channelized;

- Point-to-Multipoint High Capacity (DS1)-Hub Arrangement;
- Point-to-Multipoint Very High Capacity (DS3)—Hub Arrangement;
- Multipoint Digital Bridge Service;
- End Link Point to Multipoint Voice Grade-Full Bandwidth;
- End Link Point to Multipoint Digital Data (DS0)—Full Bandwidth;
- End Link Point to Multipoint High Capacity (DS1)—Full Bandwidth;
- End Link Point to Multipoint High Capacity (DS1)—Channelized;
- End Link Point to Multipoint Very High Capacity (DS3)--Channelized;
- SONET DS1 Interfaces;
- Optional Feature: Hub to Hub connection—DS0 and DS1;
- Optional Feature: ILEC Central Office Collocation Cross Connects—DS0 and DS1;
- Optional Feature: ILEC Central Office Multiplexing-DS0 and DS1; and
- Optional Feature: Metro Private Line Multiplexing-DS0-DS3.
  - b. MCIU.S. Private Line Services

The MCI Entities' U.S. Private Line services provide private line transmission service in the contiguous United States and Washington, DC, originating in a Company-designated point-of-presence (POP) in one Local Access Transport Area (LATA) and terminating in a Company-designated POP in another LATA via interexchange carrier (IXC) transport. U.S. Private Line services offer a suite of analog, digital, and SONET services available on point-to-point, point-to-multipoint, and multipoint configurations. The following specific U.S. Private Line services are covered by this Application:

- Analog point-to-point, point-to-multipoint and multipoint configurations
- Digital DS0 point-to-point, point-to-multipoint and multipoint configurations
- Point-to-point Fractional DS1 (DS1)

- Point-to-point Digital DS1 (Digital Signal Level 1)
- Optional feature: Web Digital Reconfiguration Services (Web DRS); and
- Optional feature: Echo Control

#### c. Verizon Long Distance National Private Line Services

The services that Verizon Long Distance seeks to discontinue are certain National Private Line services. National Private Line services are a family of bandwidth and data services that link customers' locations and provide voice, data, video and other transmissions. The following National Private Line services are covered by this application:

- All DS0 Services, including Digital Data Service (DDS) B, Analog Data B, Analog Voice (2 Wire and 4 Wire) B
- Fractional DS1/T1 (FDS1) Service
- DS1/T1 (DS1) Service
- DS3/T3 (DS3) Service

# 5. Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71 (c)(3)):

Customers that currently subscribe to the Affected Services were sent notices by U.S.

mail on or before April 15, 2021. Representative copies of the notices are attached as Exhibit A.

Separately, on or before April 15, 2021, copies of this Application were sent by U.S. mail

to the governor and public utilities commission of each affected state, to federally-recognized

tribal nations in each affected state, and to the Department of Defense Chief Information Officer,

as required by Section 63.71(a) of the Commission's rules.

#### 6. Regulatory Classification of Carrier (47 C.F.R. § 63.71(c)(4)):

The MCI Entities and Verizon Long Distance are all classified for regulatory purposes under the Commission's rules as non-dominant with respect to the services to be discontinued.

#### CONCLUSION

The MCI Entities and Verizon Long Distance respectfully request that the Commission approve this Application.
