UBTA-UBET Communications Inc., dba STRATA Networks, Study Area Code 502287, hereby provides notice to the Wireline Competition Bureau that the Cooperative is detariffing its packet-based and higher capacity TDM (non-ex ante) business data services (BDS), effective July 1, 2021.

UBTA-UBET Communications Inc., dba STRATA Networks is a rate-of-return carrier that receives Alternative Connect America Cost Model (A-CAM) support and elected incentive regulation for its BDS offerings,¹ effective as of July 1, 2020. This detariffing will apply to the entirety of the Cooperative's service area in the state of Utah. All rates, terms, and conditions for non-ex ante BDS offerings will be provided upon request. UBTA-UBET Communications Inc., dba STRATA Networks will continue to offer lower capacity TDM transport and end user channel termination (ex ante) BDS under the incentive regulation framework in the Moss Adams FCC Tariff No. 1.

A copy of this notice is also being sent to existing customers of the affected services, the State of Utah Public Service Commission, the Governor of Utah, and the Special Assistant for Telecommunications at the Department of Defense.
