By letter order issued on September 19, 2022 in Docket No. RP22-1179-000, the Federal Energy Regulatory Commission ("Commission") accepted the proposed tariff records to be effective on October 1, 2022. The tariff records add a new non-conforming transportation service agreement to CIG's Tariff.

By letter order issued on September 28, 2022 in Docket No. RP22-1180-000 and RP22-1180-001, the Commission accepted the proposed tariff record to be effective on October 1, 2022. The tariff record updates CIG's fuel and lost and unaccounted for reimbursement percentages.

The attached files distribute the latest changes to CIG's Tariff.
