Recommendation (No Action Required)

Attached for your information is the latest status report on the Utah Universal Service Fund (UUSF). All reported amounts are proprietary.

The UUSF showed a balance of \$17,049,590 at the end of January 2022, which is a decrease of \$135,102 from the previous month. Contributions for the month were \$1,399,222. High cost support disbursed to rural ILECs totaled \$1,507,495. Other expenses include Speech and Hearing Impaired disbursements of \$26,795 and Interactive Transaction Fees of \$34. The total distributions and expenses were \$1,534,323.

In January, 136 providers remitted UUSF payments based on connections. There were 3,766,906 connections subject to surcharge reported. Exempt connections claimed by providers totaled 3,412.
