Dear Secretary Bose:

Pursuant to Part 154 of the regulations of the Federal Energy Regulatory Commission ("FERC" or "Commission"), and in accordance with Section 12.10 of the General Terms and Conditions of its FERC Gas Tariff ("Tariff"), Third Revised Volume No. 1, Kern River Gas Transmission Company ("Kern River") hereby submits a report supporting its gas compressor fuel reimbursement factors and lost and unaccounted-for gas ("L&U") reimbursement factors for calendar year 2022.

Exhibit A: Compressor Fuel Use, January 2022 - December 2022

Exhibit A shows, by month, for each gas compressor station on Kern River's system, the following: scheduled receipts, posted fuel reimbursement factors, fuel reimbursed, fuel used, the difference between fuel reimbursed and fuel used, and cumulative imbalances.

The information on Exhibit A is reported separately for Kern River's rolled-in rate shippers (original system and 2002 expansion project shippers), its incremental rate shippers (2003/2010 expansion project shippers) and its Apex expansion project shippers because each group of shippers is subject to different gas compressor fuel reimbursement factors.¹ Information for authorized overrun/interruptible transportation services is also reported separately on Exhibit A.

¹ The procedure for allocating compressor fuel usage among the shipper groups was revised effective October 1, 2011, when Kern River's Apex expansion project was placed in service. (*See* letter order issued September 16, 2011, in Docket No. RP11-2512-000.)

Exhibit B: Lost and Unaccounted-for Gas ("L&U"), January 2022 – December 2022

Exhibit B, Page 1, provides monthly information on system-wide L&U, less High Desert Lateral L&U described below, as follows: scheduled receipts, posted L&U reimbursement factors, total L&U reimbursed, actual L&U, the difference between L&U reimbursed and actual L&U, and the cumulative L&U imbalance. All system-wide shippers reimburse Kern River for L&U at the same rate.

Exhibit B, Page 2, provides monthly information on the High Desert Lateral L&U as follows: scheduled receipts, posted L&U reimbursement factors, total L&U reimbursed, actual L&U, the difference between L&U reimbursed and actual L&U, and the cumulative L&U imbalance. The High Desert Lateral L&U is reported separately from the system-wide L&U because shippers on the High Desert lateral are subject to L&U reimbursement that is specific to the High Desert lateral.

Exhibit C: 2022 Net Benefit Computation

In an order issued July 26, 2001² pertaining to Kern River's 2002 expansion project, the Commission determined that Kern River should roll-in the costs of its 2002 expansion project. The Commission directed Kern River to submit a work paper showing the net benefit to vintage shippers of rolling in the 2002 expansion project, after actual fuel costs were considered, when it submits a filing to revise its electric compressor fuel surcharges and when it files its annual gas compressor fuel reimbursement report.

Attached, as Exhibit C, is Kern River's Net Benefit Computation for the period from January 1, 2022 through December 31, 2022. As shown on Exhibit C, there was a positive net benefit for calendar year 2022.

Related Filing

The Net Benefit Computation submitted herewith as Exhibit C is the same as Exhibit B to the filing Kern River submitted February 28, 2023, in Docket No. RP23-477 to revise the Daggett electric compressor fuel surcharges, effective April 1, 2022.

NOTES TO EXHIBIT A: December

Procedure for Allocating Authorized Overrun Service and Interruptible Service (AOS/IT) Compressor Fuel Reimbursement between Rolled-in, Incremental and Apex Shippers.

The allocation procedure described below uses an example based on the Salt Lake compressor for December 2022. Although Kern River provides monthly information in this report, *the calculations are performed on a daily basis, which may produce slight differences in the report and in this example due to rounding.*

Step 1: Total fuel reimbursement for AOS/IT service is determined by multiplying total scheduled AOS/IT receipts at each compressor by the posted fuel rate applicable to AOS/IT service, which is a blended rate based on 39.6% of the Rolled-in rate, 48.2% of the Incremental rate and 12.2% of the Apex rate.

Example: For the month of December 2022, total scheduled receipts for AOS/IT service through the Salt Lake compressor were **2,034,984 Dths**. The total scheduled receipts for each day were multiplied by 0.0010, the blended fuel rate applicable to AOS/IT service at that compressor for December 2022 ((0.0006×0.396) + (0.0012×0.482) + (0.0014×0.122)), to arrive at a daily fuel reimbursement amount. The sum of the daily fuel reimbursements for December 2022 was **2,035 Dths**.

<u>Step 2</u>: The total scheduled AOS/IT receipts were allocated between the Rolled-in, Incremental and Apex rate groups by multiplying the total receipts by 39.6%, 48.2% and 12.2%, respectively, and the allocated receipts for each rate group were then multiplied by the fuel reimbursement factor applicable to each rate group.

Example: Of the total scheduled AOS/IT receipts of **2,034,984 Dths**, **805,855 Dths** (39.6%) was allocated to the Rolled-in group, **980,862 Dths** (48.2%) was allocated to the Incremental group, and **248,267 Dths** (12.2%) was allocated to the Apex group. The fuel reimbursement initially credited to the Rolled-in group was **484 Dths** (805,855 x 0.0006), the fuel reimbursement initially credited to the Incremental group was **1,177 Dths** (980,862 x 0.0012), and the fuel reimbursement initially credited to the Apex group was **348 Dths** (248,267 x 0.0014), for a total of **2,008 Dths** -- which differs from the actual fuel reimbursed by the AOS/IT group (**2,035 Dths**)., making the following steps necessary:

Step 3: The fuel reimbursement calculated in Step 2 above for each rate group was divided by the total fuel reimbursement calculated in Step 2 to determine the reimbursement percentage applicable to each rate group.

Example: (484 / 2,008 = .2408 for the Rolled-in group, 1,177 / 2,008 = .5861 for the Incremental group, and 348 / 2,008 = .1731 for the Apex group).

Step 4: The total fuel reimbursement calculated in Step 1 was multiplied by the applicable percentage for each rate group calculated in Step 3 to determine the fuel reimbursement to be credited to each rate group.

Example: (2,035 x .2408 = 490 for the Rolled-in group, 2,035 X .5861 = 1,193 for the Incremental group and 2,035 x .1731 = 352 for the Apex group). Total fuel reimbursement for AOS/IT service to be credited equals 2,035 Dths.
