SECTION 63.71 APPLICATION

CenturyLink Communications, LLC (FRN: 0018-4219-41), 1 f/k/a Embarg

Communications, LLC and also f/k/a Qwest Communications Company, LLC d/b/a CenturyLink QCC, (referred to herein as "CenturyLink") hereby applies for authority to discontinue service to its remaining customers of various Voice over Internet Protocol ("VoIP") services that have operated on a VoIP platform, known as Sylantro, that has reached the end of its service life and is no longer technically supported. Pursuant to Federal Communications Commission ("Commission") authority, these services were grandfathered in 2018.² CenturyLink now

requests Commission authority to discontinue these services in all fifty states and the District of Columbia.

CenturyLink submits the following information in support of its application:

1. Name and address of carrier

2. Date of planned service discontinuance

CenturyLink plans to discontinue the Affected Services on September 29, 2023, or as soon thereafter as any necessary regulatory approvals are obtained.

3. Points of geographic areas of service affected

CenturyLink seeks authority to discontinue the services supported by the Sylantro VoIP platform in all 50 states and Washington D.C.

4. Brief description of the type of services affected

CenturyLink is seeking to discontinue the VoIP services provided by the Sylantro VoIP platform, which are:

- Qwest OneFlex Hosted VoIP: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.
- Qwest OneFlex Integrated Access Analog and Digital: An IP-based solution that integrates local and long-distance voice with Internet access on a single connection.
- Qwest Managed VoIP: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.
- Qwest Hosted VoIP: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.
- Qwest IQ Managed VoIP Bundle: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.

5. Brief description of the dates and methods of notice to all affected customers

CenturyLink sent a written notification of the planned discontinuance to customers affected by the proposed discontinuance in accordance with Section 63.71(a) of the Commission's Rules. Customer notifications were sent by U.S. Mail or United Parcel Service on May 2, 2023. A copy of the notification is attached to this application (Attachment A).

6. Dominance of carrier with respect to the service to be discontinued

CenturyLink is a non-dominant carrier with regard to services supported by the Sylantro VoIP platform.

7. Service

In accordance with 47 C.F.R. § 63.71(a), CenturyLink has mailed a copy of this application to the Governor and public utility commission of each of the affected states and jurisdictions identified in Paragraph 3 above, to any federally-recognized Tribal Nations with authority over the Tribal lands in the geographic areas identified in Paragraph 3 above, as well as to the Special Assistant for Telecommunications under the Secretary of Defense.

Important Notice Regarding the Planned Discontinuance of Certain Voice Over the Internet (VoIP) Service Provided by CenturyLink Communications, LLC, a Lumen Company

Dear _____,

At CenturyLink Communications, LLC, a Lumen company (CenturyLink), our goal is to provide you with great quality and value while remaining competitive. Changing market conditions require that we continually evaluate our pricing, product offerings and infrastructure.

In 2018, we stopped the sale of the services identified in Attachment A (Affected Services), including your ability to make moves, adds, or changes. We are now writing to inform you that, as of September 29, 2023, or as soon after that date as authorized by the Federal Communications Commission (FCC) and the state regulatory commission, if required, the Affected Services will be discontinued and CenturyLink will no longer provide VoIP service over the Sylantro VoIP platform in all fifty (50) states and the District of Columbia.

In order to maintain continuous service at your location, we would like to work with you to migrate your existing service to a similar service or another state-of-the-art platform that will provide your business with greater flexibility, simplicity, and efficiency. The good news is that CenturyLink offers multiple VoIP solutions with new technology, capabilities and features to enhance your communication experience including Hosted VoIP and IQ SIP Trunk (native SIP or PRI handoff).

If you have not planned with CenturyLink or another telecommunications service provider to replace your voice service listed in Attachment A prior to September 29, 2023, your service will be disconnected, provided that the FCC and state commission, if required, approve the planned VoIP platform discontinuance.
