**SECTION 63.71 APPLICATION OF
MCIMETRO ACCESS TRANSMISSION SERVICES LLC**

MCImetro Access Transmission Services LLC (“MCI”) submits this Application for authority under Section 214(a) of the Communications Act and Section 63.71 of the Commission’s rules to discontinue Small Business and Residential Local Phone service (the “Affected Service”) as specified below. MCI offers the Affected Service only to small business and residential customers as a competitive LEC. As discussed below, to the best of MCI’s information and belief, for each customer, a TDM-based voice service will continue to be available from another provider. Affected customers can also choose from multiple modern services that include any-distance voice calling and other capabilities offered over technologies such as cable, fiber, or wireless.

Consistent with Section 63.71(a) and (c) of the Commission’s rules, MCI provides the following information:

1. Name and Address of Carrier (47 C.F.R. §§ 63.71 (a)(1), (c)(2)):

2. Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (c)(2)):

Subject to the Commission's authorization, on or after December 31, 2023, MCI will discontinue the Affected Service in the geographic areas identified in Section 3 below.

3. Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), (c)(2)):

Subject to the Commission's authorization, MCI will discontinue the Affected Service in Alabama, Arizona, Arkansas, California, Colorado, Connecticut, Florida, Georgia, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Washington, Wisconsin, and Wyoming.

4. Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(4), (c)(2)):

Offered by MCI as a competitive LEC, Small Business and Residential Local Phone service provides a single analog TDM voice communications circuit for a customer's telephone. The service is a solution for routine voice telecommunications applications which provides an access line to the end user customer, allowing the customer to place and receive local calls and to access the interexchange carrier selected by the customer for interLATA, intraLATA, interstate, or international calling.¹

MCI is discontinuing Small Business and Residential Local Phone service because demand has declined significantly. Many customers have already chosen to migrate away from the Affected Service, including to services offered over technologies such as fiber, cable, or wireless that offer flexibility and reliability and are suitable for both any-distance voice

communications and next generation applications. MCI plans to work with the remaining customers who could be affected by this change by providing ample notice of the discontinuance and multiple touch points and, if a customer chooses to migrate to another provider, will work with the customer and the new provider to transition the customer's service.

TDM Alternative Services and Products: MCI's discontinuance of Small Business and Residential Local Phone service is not a "Technology Transition" as defined in 47 C.F.R. § 63.60(i) because customers are not required to replace their service with a different technology or medium for transmission. To the best of MCI's information and belief, a facilities-based provider will continue to offer a TDM-based wireline voice solution at all of the locations where MCI has Small Business and Residential Local Phone customers. A list of incumbent LEC providers of TDM voice service at Small Business and Residential Local Phone service customer locations is attached as Exhibit A.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71 (c)(3)):

Customers of the Affected Service were sent notices by bill message on or before the date of this Application. A representative copy of the bill messages is attached as Exhibit B.

Customers of the Affected Service were also sent notices by letter on or before the date of this Application. A representative copy of the letters is attached as Exhibit C.

Separately, on or before the date of this Application, copies of this Application were sent by U.S. mail to the governor and public utilities commission of each affected state, to federally-recognized tribal nations in each affected state, and to the Department of Defense Chief Information Officer, as required by Section 63.71(a) of the Commission's rules.

6. Regulatory Classification of Carrier (47 C.F.R. § 63.71(c)(4)):

MCI is classified for regulatory purposes under the Commission's rules as non-dominant with respect to the Affected Service.

CONCLUSION

MCI respectfully requests that the Commission approve this Application.

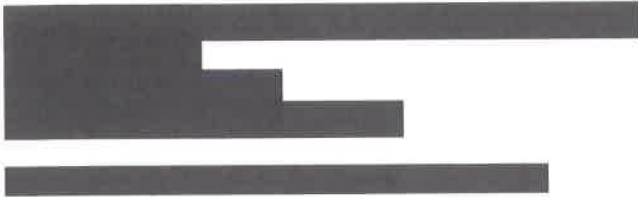
