**SECTION 63.71 APPLICATION OF
MCI COMMUNICATIONS SERVICES LLC;
MCIMETRO ACCESS TRANSMISSION SERVICES LLC; AND
MCIMETRO ACCESS TRANSMISSION SERVICES OF VIRGINIA, INC.**

MCI Communications Services LLC; MCImetro Access Transmission Services LLC; and MCImetro Access Transmission Services of Virginia, Inc. (collectively, the “MCI Entities”) submit this Application for authority under Section 214(a) of the Communications Act and Section 63.71 of the Commission’s rules to discontinue U.S. Private Line Service (“USPL”) at off-net locations and three versions of Metro Private Line Access Service (“MPL”) at off-net locations as specified below.¹ In some customer locations, the MCI Entities offer USPL and MPL (collectively, the “Affected Services”) using their own or another Verizon entity’s last-mile facilities (“on-net”) whereas in other customer locations the MCI Entities offer the Affected Services using a non-Verizon entity’s last-mile facilities (“off-net”). This Application applies

only to off-net locations and does not apply to on-net locations. None of the Affected Services is sold to residential or consumer customers, and none of the Affected Services is plain old telephone service (“POTS”).

Consistent with Section 63.71(a) and (c) of the Commission’s rules, the MCI Entities provide the following information:

2. Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (c)(2)):

Subject to the Commission’s authorization, on or after December 31, 2023, the MCI Entities will discontinue the Affected Services at off-net locations in the geographic areas identified in Section 3 below.

3. Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), (c)(2)):

Subject to the Commission’s authorization, the MCI Entities will discontinue USPL at off-net locations in the contiguous 48 U.S. states and the District of Columbia.

Subject to the Commission’s authorization, the MCI Entities will discontinue the three versions of MPL, as described in Section 4 below, at off-net locations in the contiguous 48 U.S. states and the District of Columbia.

4. Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(4), (c)(2)):

Metro Private Line Access provides dedicated access when one of its variants is deployed but the majority of MPL service is over the shared network. MPL can also be used as a standalone metro service. Three versions of MPL are covered by this Application: (1) Digital Metro Private Line Access Service; (2) Metro Private Line Optical SONET Service; and (3) Metro Storage Transport Service. Only off-net locations are covered by this Application.

U.S. Private Line provides private line transmission service within the contiguous U.S. 48 states and the District of Columbia on point-to-point, point-to-multipoint, and multipoint configurations. All versions of USPL are affected. Only off-net locations are covered by this Application.

The MCI Entities are discontinuing the Affected Services because recently various underlying carriers that provide last-mile access at off-net locations have implemented or announced significant rate increases or they have notified the MCI Entities that they will cease providing access solutions. As a result, the MCI Entities have decided to discontinue the Affected Services at off-net locations.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71 (c)(3)):

Customers of the Affected Services were sent notices by bill message on or before the date of this Application. A representative copy of the bill messages is attached as Exhibit A.

Separately, on or before the date of this Application, copies of this Application were sent by U.S. mail to the governor and public utilities commission of each affected state, to federally-recognized tribal nations in each affected state, and to the Department of Defense Chief Information Officer, as required by Section 63.71(a) of the Commission's rules.

6. Regulatory Classification of Carrier (47 C.F.R. § 63.71(c)(4)):

The MCI Entities are classified for regulatory purposes under the Commission's rules as non-dominant with respect to the Affected Services.

CONCLUSION

The MCI Entities respectfully request that the Commission approve this Application.

Subtitle: Notice of discontinuation of service

On or after December 31, 2023 Verizon is discontinuing the US Private Line and Metro Private Line services detailed in this message. They will be disconnected on or after December 31, 2023 at off-net locations only.

At some customer locations, Verizon provides the Affected Services using other providers' last-mile facilities ("off net"), whereas at other customer locations Verizon provides the Affected Services over its own last-mile facilities ("on-net").

These changes are subject to any applicable regulatory and contractual obligations. Therefore, these changes do not apply to federal agencies; these changes also do not apply to state, local government and educational agencies who purchase these services under such agencies' own master contracts.

The number(s) next to each service name in the table below refers to the Verizon companies that provide each service, as detailed at the end of this message.

Circuits provided using last-mile facilities owned by any Verizon entity ("on-net") are not impacted by this action - only those provided using another provider's last-mile facilities ("Off-net") will be affected.

Description: Metro Private Line Access Service provides dedicated access when one of its variants is deployed but the majority of MPL service is over the shared network. MPL can also be used as a standalone metro service.

The service is provided on an interstate and intrastate basis.
