**SECTION 63.71 APPLICATION OF  
XO COMMUNICATIONS SERVICES, LLC AND XO VIRGINIA, LLC**

XO Communications Services, LLC and XO Virginia, LLC (collectively, “XO”)<sup>1</sup> submit this Application for authority under Section 214(a) of the Communications Act and Section 63.71 of the Commission’s rules to discontinue<sup>2</sup> the following services (collectively, the “Affected Services”) sold to retail business customers as specified below:

- XO Dedicated Transport Service;
- XO IP Virtual Private Network Service;
- XO Enterprise Session Initiation Protocol (“ESIP”);
- XO IP Flex;
- Long Distance and toll-free services offered in association with XO IP Flex and XO ESIP (the “Affected Services”).

These services (collectively, the “Affected Services”) are offered by XO as a competitive LEC. XO does not sell the Affected Services to residential or consumer customers, and none of the Affected Services is plain old telephone service (“POTS”).

Consistent with Section 63.71(a) and (c) of the Commission’s rules, XO provides the following information:

**2. Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (c)(2)):**

Subject to the Commission’s authorization, on or after January 15, 2024, XO will discontinue the following speeds of XO Dedicated Transport Service: DS-3 service, Local Loop Service, Ethernet access solutions delivered over TDM (EoTDM), and Metro Service. Subject to the Commission’s authorization, on or after May 31, 2024, XO will discontinue all other speeds of XO Dedicated Transport Service.

Subject to the Commission’s authorization, on or after May 31, 2024, XO will discontinue XO IP Virtual Private Network Service, XO ESIP, XO IP Flex, and Long Distance and toll-free services offered in association with XO IP Flex and XO ESIP.

**3. Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), (c)(2)):**

Subject to the Commission’s authorization, XO will discontinue the Affected Services in the contiguous 48 U.S. states and the District of Columbia.

**4. Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(4), (c)(2)):**

The services XO seeks to discontinue are:

*XO Dedicated Transport Service* provides a high-capacity telecommunications capability available as point-to-point E-line and point-to-multipoint hub configurations. It may be configured using fiber, copper, or wireless access technologies. XO Dedicated Transport Service is also known as XO Carrier Dedicated Transport Service, Ethernet Private Line, Ethernet point-to-point, Ethernet Access, Ethernet Serial Access, Off Net, OnNet Fiber, Ethernet over Copper (EoC) Circuit, Ethernet over Sonet (EoS) Circuit, Ethernet Hub, End Link, Wavelength, Ethernet, Wavelength Private Line TDM Transport, IntereXchange (IX), Local Loop (LL), Point to Point, Long Haul, Metro Hub, National Hub, End Link, Muxed, SONET, SONET Ring.

*XO IP Virtual Private Network Service* is a layer 3 data networking service that supports traditional private networking services over a multiprotocol label switching (MPLS)-enabled IP backbone. XO IP Virtual Private Network Service is also known as Access Circuit, Internet Protocol Virtual Private Network Multi-Protocol Label Switching (IP-VPN MPLS), Internet Protocol Virtual Private Network Virtual Private LAN Service (IP-VPN VPLS).

*XO Enterprise Session Initiation Protocol (“ESIP”)* uses a centralized IP-PBX at a primary location to deliver Voice over IP to other company locations using an existing private network or the XO MPLS IP-VPN Service.

*XO IP Flex* is a simple bundle of business communications services that includes local and long distance voice, Internet, and a variety of popular calling features. XO IP Flex is also known as XOptions Flex.

***Long Distance and toll-free services offered in association with XO IP Flex and XO ESIP.*** These services provide interstate voice and VOIP communications, either inbound or outbound, and allow customers to make domestic and international long distance calls.

***Alternative Services and Products:*** Customers today may obtain alternative services and products from Verizon or other providers that perform similar functions as these services. Alternative products and services offered by Verizon include Verizon VoIP IP Trunking and Verizon Inbound and Outbound Long Distance Services. Verizon will work with interested customers to find suitable alternative solutions offered by Verizon.

**5. Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71 (c)(3)):**

Customers of the Affected Services were sent notices by bill message on or before the date of this Application. A representative copy of the bill messages is attached as Exhibit A.

**6. Regulatory Classification of Carrier (47 C.F.R. § 63.71(c)(4)):**

XO is classified for regulatory purposes under the Commission's rules as non-dominant with respect to the Affected Services.

**CONCLUSION**

XO respectfully requests that the Commission approve this Application.

The following speeds will be discontinued on or after January 15, 2024: DS-3 service, Local Loop Service, Ethernet access solutions delivered over TDM (EoTDM), and Metro Service. This date supersedes previous notices you received about these speeds.

All remaining service speeds will be discontinued on or after May 31, 2024.

2. **XO IP Virtual Private Network Service.** This is a layer 3 data networking service that supports traditional private networking services over a multiprotocol label switching (MPLS)-enabled IP backbone

Also known as Access Circuit, Internet Protocol Virtual Private Network Multi-Protocol Label Switching (IP-VPN MPLS), Internet Protocol Virtual Private Network Virtual Private LAN Service (IP-VPN VPLS).

This service will be discontinued on or after May 31, 2024.

3. **XO Enterprise Session Initiation Protocol (ESIP).** ESIP uses a centralized IP-PBX at a primary location to deliver Voice over IP to other company locations using an existing private network or the XO IP-VPN MPLS Service.

This service will be discontinued on or after May 31, 2024.

4. **XO IP Flex (a.k.a. XOptions Flex).** A simple bundle of business communications services that includes local and long distance voice, Internet, and a variety of popular calling features.

This service will be discontinued on or after May 31, 2024.

5. **Long Distance and toll-free services offered in association with XO IP Flex and XO ESIP.**

This includes the following plans provide inter-state voice and VOIP

communications, either inbound or outbound, and allow customers to make national and international long distance calls: Ded/Dial International RP; Dial Tone International RP; Dial Tone RP; ELD NPA NXX Rate Plan; IP LD 50K RP; IP LD Business Plan; IP Local LD 100K RP; IP TF 5K RP; Long Distance Business RP; Resale Local Rate Plan; RP C24 Fin ICB; DT Ded .045; RP Directory Assistance; RP Finance ICB DT Ded .045; RP Local; Usage Zero; RP NT Dial Tone LD; Unlimited; LD RP; Unlimited Local RP; XO Global Calling Plan; XOP Local RP; XOP Long Distance RP 5-04. These long distance and toll-free services will be discontinued on or after May 31, 2024.

These services are being discontinued in the contiguous 48 U.S. states and the District of Columbia.
