NOTICE OF WITHDRAWAL OF COMCAST IP PHONE, LLC'S NOVEMBER 10, 2023, LETTER

Comcast IP Phone, LLC ("Comcast") hereby withdraws its November 10, 2023 letter informing the Public Service Commission of Utah of Comcast's planned interconnection arrangement to serve customers in Eagle Mountain, Utah, in the above captioned docket. This Notice of Withdrawal is made pursuant to the January 12, 2024, letter from Chris Parker, Director of the Utah Department of Commerce, Division of Public Utilities, "the services requested are merely transport, not local exchange services to end customers" and "[n]either the Division nor the Commission regulates the provision of those wholesale services in this context." *See* Exhibit A.

Ms. Somers,

I am following up on our conversation about Comcast's plan to provide VoIP service to Eagle Mountain, Utah. My understanding of the plan is based on the November 14, 2023, Comcast IP Phone, LLC ("Comcast") filing with the Public Service Commission indicating Comcast's plan to indirectly exchange local voice traffic with Direct Communications Cedar Valley, LLC ("Direct") to provide these services. This would also use facilities and services from Qwest Corporation d/b/a CenturyLink QC ("Lumen"). I see no statutory issues with Lumen providing these services because the services are merely transport, not local exchange services to end customers. Neither the Division nor the Commission regulates the provision of those wholesale services in this context.
