Re: Docket No. 23-999-06, Utah Universal Service Fund Status.

Recommendation (No Action)

Attached for your information is the latest status report on the Utah Universal Service Fund (UUSF). All reported amounts are proprietary.

The UUSF showed a balance of \$14,805,700 at the end of January 2023, which is a decrease of \$594,183 from the previous month. Contributions for the month were \$1,499,095. High-cost support disbursed to rural ILECs totaled \$1,800,007. Other expenses include PSC Speech and Hearing disbursements of \$36,095, Interactive Transaction Fees of \$39, and Lifeline Biannual payments of \$257,138. The total distributions and expenses were \$2,093,279.

In January, 153 providers remitted UUSF payments based on connections. There were 4,059,103 connections subject to surcharge reported. Exempt connections claimed by providers totaled 3,514.
