Dear Acting Secretary Reese:

Pursuant to Part 154 of the regulations of the Federal Energy Regulatory Commission (“Commission” or “FERC”), Kern River Gas Transmission Company (“Kern River”) hereby tenders for filing and acceptance the following tariff sheets as part of its FERC Gas Tariff, Third Revised Volume No. 1 (“Tariff”), to be effective March 1, 2024:

Purpose

The purpose of this filing is to add a new market area pool point to Section 22 of the General Terms and Conditions (“GT&C”) of Kern River’s Tariff, “Pooling and Title Transfer Tracking.”

Statement of Nature, Reasons and Basis for the Filing

Section 22.1(b)(2) of the GT&C lists all the market area pools on Kern River’s system and the delivery points associated with each of those pools. Kern River proposes to revise this section to establish the “Special Use Northern Utah Firm Pool” and “Special Use Northern Utah AOS/Interruptible Pool” for use by shippers with special rate provisions applicable to delivery points solely served by Kern River. The proposed language will be inserted as subsection “(iii)” to maintain the geographic order from Wyoming to California in Section 22.1(b)(2).

The need for this special pool is due to the addition of the new Bayview delivery meter which is solely connected to Kern River. The Bayview delivery meter is located in the Northern Utah Firm Pool area between the Salt Lake and Elberta compressor stations.

The revisions reflected in this filing are administrative only and do not affect the substantive rights of the shippers. Therefore, Kern River respectfully requests that the Commission accept the proposed revision.

Waivers and Effective Date

Kern River respectfully requests that the Commission accept the tendered tariff sheets to be effective March 1, 2024, or at the end of any minimal suspension period that may be ordered by the Commission. Kern River also requests that the Commission grant any waivers it may deem necessary for the acceptance of this filing.

In accordance with Section 154.208, Kern River has served an electronic copy of this filing upon its customers and interested state regulatory commissions.
