Recommendation (No Action)

Attached for your information is the latest status report on the Utah Universal Service Fund (UUSF). All reported amounts are proprietary.

The UUSF showed a balance of \$6,416,221 at the end of April 2024, which is a decrease of \$358,712 from the previous month. Contributions for the month were \$2,639,810. High-cost support disbursed to rural ILECs totaled \$2,942,966. Other expenses include PSC Speech and Hearing disbursements of \$55,511, Interactive Transaction Fees of \$44. The total distributions and expenses were \$2,998,521.

In April, 144 providers remitted UUSF payments based on connections. There were 3,720,659 connections subject to surcharge reported. The connections vary from month to month. There were a few companies who paid with the previous surcharge and have been notified. Exempt connections claimed by providers totaled 9,776.
