In recent correspondence regarding Rocky Mountain Power's (RMP) 2024 Utah Carbon Reduction Progress Report ("Report"), the Public Service Commission (PSC) indicated its intent to open a miscellaneous docket "seeking stakeholder input regarding: (1) the recognition or issuance of Renewable Energy Credits (RECs) that predate Western Renewable Energy Generation Information System (WREGIS) certification; (2) how credit will be applied towards the target for the 2.4 multiplier for the amount for photovoltaic and solar energy as contemplated in Utah Code Ann. § 54-17-603(6); (3) clarification on whether the 20 percent target becomes an annual target in post-2025 under Utah Code Ann. § 54-17-602; and (4) whether additional action on the process¹ for the issuance, monitoring, accounting, transfer, recognition,

and use of a REC with respect to Utah Code Ann. § 54-17-601 to -607 ("Part 6") is necessary."²

NOTICE OF TECHNICAL CONFERENCE

Accordingly, a technical conference will be held in this docket on **Tuesday, April** 9, 2024, beginning at 10:00 a.m., Fourth Floor Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.

The PSC requests that RMP provide further explanation about the outstanding issues mentioned above, including how any of the other states within its service territory recognize RECs that predate WREGIS certification, at the beginning of the technical conference. This will provide an opportunity for RMP and all interested stakeholders to engage, present proposals, and describe their preliminary positions interpreting the statutes mentioned in items (2)-(4) above.³ To help ensure efficient use of stakeholder time, interested stakeholders are encouraged to file proposals on the recognition of pre-WREGIS REC certification and preliminary positions as to items (2)-(4) by April 1, 2024. After the technical conference, the PSC will evaluate the
