On August 1, 2025, Corix Utah City Heating and Cooling LLC (“Corix”) filed an application (“Application”) with the Public Service Commission (PSC) seeking a certificate of public convenience and necessity “authorizing [it] to construct, own, and operate a ‘heat corporation,’ as defined [in Utah Code], offering heating and cooling services operated in combination for the Utah City District Energy Utility ... system in the area of the city of [Vineyard, Utah].”<sup>1</sup> Corix requested the Application be adjudicated informally.

On August 7, 2025, the Office of Consumer Services (OCS) filed a Request for Scheduling Conference wherein OCS, among other things, opposes Corix’s request for informal adjudication of this docket and seeks a scheduling conference.

This docket will thus be adjudicated formally. Accordingly, the PSC gives notice it will conduct a scheduling conference with respect to the above-referenced docket on **Monday, August 25, 2025, at 1:00 p.m.** The conference will be held via Zoom at the following link: (<https://utah-gov.zoom.us/j/6041317806?omn=86752616954>).
