Rocky Mountain Power’s Motion to Excuse Party from Corix CPCN Application Hearing

PacifiCorp d/b/a Rocky Mountain Power (“Rocky Mountain Power”) respectfully moves the Public Service Commission of Utah (“Commission”) to excuse Rocky Mountain Power from attending the Corix CPCN Application Hearing, scheduled to begin December 9, 2025. Rocky Mountain Power filed a petition to intervene on August 22, 2025, which was granted by the Commission on September 8, 2025. Rocky Mountain Power submitted discovery to Corix on October 3, 2025, to gain a better understanding of the services Corix intends to provide and confirm Corix does not intend to operate as an electric utility. As stated in Rocky Mountain Power’s Initial Comments, filed on October 29, 2025, based on Corix’s responses to Rocky Mountain Power’s discovery questions, Rocky Mountain Power does not oppose Corix’s Application for CPCN approval. Rocky Mountain Power does not intend to call witnesses on behalf of Rocky Mountain Power, nor does it intend to


cross-examine any witnesses in the Corix CPCN Application Hearing on December 9, 2025.


