**Rocky Mountain Power Q2 2025 Hourly Qualifying Facility Purchases Report -
Kennecott Smelter / Kennecott Refinery / Tesoro / US Magnesium**

In its December 23, 2009 order in Docket No. 09-035-20 approving qualifying facility (“QF”) sales from US Magnesium to Rocky Mountain Power (“RMP” or “Company”), and in subsequent approvals, the Public Service Commission of Utah (“UPSC”) directed RMP to provide hourly power purchased under the power purchase agreement (“PPA”) on a quarterly basis. In accordance with that order, RMP provides the hourly delivered energy from US Magnesium for Q2 2025 (January 1, 2025 through June 30, 2025). Similarly, the Company also provides hourly power purchased under the equivalent PPAs for Kennecott Smelter and Kennecott Refinery (Docket No. 08-035-83) and Tesoro (Docket No. 08-035-82). The enclosed information is confidential and provided under the terms of the protective order in each of these dockets.


