Re: Notice of Non-Competitive Procurement with Summit Line Construction

Dear Commissioners:

In accordance with PacifiCorp's ("the Company") Procurement Policy, the Company must report to the Public Service Commission of Utah ("Commission") purchases of goods or services exceeding \$1,000,000 that are not competitively bid. This letter hereby serves as notice that PacifiCorp has entered into a non-competitively bid contract with Summit Line Construction that exceeds \$1,000,000. The total contract value for the scope of work is

Pursuant to PacifiCorp's Procurement Policy, a supplier may be awarded a contract on a non-competitive basis under certain circumstances, such as when competitive bidding is impossible or impractical, or when otherwise a non-competitive procurement has been demonstrated to be in the best interest of the Company and its customers.

Summit Line was awarded a competitively-bid contract to rebuild the Company's transmission line between the Mountain Dell and Summit Park Substations, converting the operating voltage from 46kV to 138kV. To accommodate the upgrade the two substations also require additional modifications, and having one contractor complete both projects minimizes the financial risk and potential for costly delays. Additionally, Summit Line's quote for the additional scope of work matched the budgeted estimated cost.
