Re: Notice of Non-Competitive Procurement with Jaxon Engineering & Maintenance LLC.

Dear Commissioners:

In accordance with PacifiCorp's ("the Company") Procurement Policy, the Company must report to the Public Service Commission of Utah ("Commission") purchases of goods or services exceeding \$1,000,000 that are not competitively bid. This letter hereby serves as notice that PacifiCorp has entered into a non-competitively bid contract with Jaxon Engineering & Maintenance LLC that exceeds \$1,000,000. The total contract value for the scope of work is for a period ending The scope of work includes a review of the electromagnetic protection design in the Company's North Temple Office redevelopment project, including identifying areas for further testing and to improve the current protection strategy.

Pursuant to PacifiCorp's Procurement Policy, a supplier may be awarded a contract on a non-competitive basis under certain circumstances, such as when competitive bidding is impossible or impractical, or when otherwise a non-competitive procurement has been demonstrated to be in the best interest of the Company and its customers.

Jaxon Engineering & Maintenance is one of a few firms that can provide the type of engineering services for the special protections required. The original design for these services was more expensive than expected, and Jaxon was the only firm that could maintain the project schedule and provide a redesign that will save in project costs. Other firms were consulted, but no other firms had both the requisite expertise and schedule availability. Jaxon's design will play a key role in maintaining critical services to Utah customers, in instances of extreme weather or terrorist attacks.
