Recommendation (No Action)

Attached for your information is the status report on the Utah Universal Service Fund (UUSF) for December 2025. All reported amounts are proprietary.

The UUSF showed a balance of \$12,221,970 at the end of December 2025, which is an increase of \$1,550,753 from the end of November 2025. Contributions for the month were \$4,769,788. High-cost support disbursed to rural ILECs totaled \$3,203,574. Lifeline distributions for the month of December totaled \$0. Other expenses include PSC Speech and Hearing disbursements of \$15,380 and Interactive Transaction Fees of \$81. The total distributions and expenses were \$3,219,035.

In December, 149 providers remitted UUSF payments based on connections. There were 4,987,961 connections subject to surcharge reported. The connections vary from month to month. Exempt connections claimed by providers totaled 6,817. These contributions are based on July 1, 2024, effective surcharge of 0.98 cents, and one true up payment deduction of \$43.53.
