Dispute Explanation:	<p>On or about October 7, 2024, KCI INC was excavating at 7789 S Canterwood Ln, Sandy, UT 84093, and struck an underground facility owned by Enbridge Gas Utah, resulting in damages of approximately \$2,664.06. KCI INC complied with the notice to operator requirements contained in UCA 54-8a-4. However, Enbridge Gas Utah failed to comply with its marking obligations set forth at UCA 54-8a-5, by failing to mark its underground facilities in the area of excavation. As such, Enbridge Gas Utah should bear the costs of repairs to its underground facilities and to any third party's property resulting from its failure to mark. KCI INC requests arbitration with Enbridge Gas Utah in order to resolve this issue.</p>
