ISSUED: July 20, 2022

On July 19, 2022, Union Pacific Railroad Company ("Union Pacific") and Logan City (collectively, the "Parties") filed a Stipulation to Stay Proceedings ("Stipulation") in this docket. Union Pacific states they filed with district court a complaint and request for a temporary restraining order (TRO) against Logan City. The court granted the TRO and set a hearing on the preliminary injunction. The Parties subsequently stayed the preliminary injunction hearing to allow for settlement negotiations. Because of the settlement negotiations between the Parties, they request the Public Service Commission (PSC) not enter a final order and to stay the proceedings in this docket until further notice from one or both of the Parties.

Given the Parties' Stipulation in this docket and for good cause appearing, the PSC enters a stay of the proceedings in this docket. If, at a future date, either Union Pacific or Logan City believes good cause exists for lifting the stay, that party should file a motion seeking to vacate the stay.
