Pursuant to Utah Code Ann. § 63-46b-9 and Utah Admin. Rule 746-100-7, L.M. Harris Company respectfully petitions the Public Service Commission of Utah (the "Commission") for leave to intervene in the above-captioned proceeding concerning Qwest Corporation's Land Development Agreements tariff provisions in the state of Utah. In support of its petition, L.M. Harris Company represents and states as follows:

1. L.M. Harris Company is a Developer/ Home Builder, developing and building over 50 homes per year in residential subdivisions throughout the state of Utah and specifically along the Wasatch Front.

2. As a Developer/ Home Builder, L.M. Harris Company is required by law to provide utilities, including telephone service, to the building lots we develop and /or the homes we build in Utah. The outcome of Qwest Corporation's LDA Tariff docket could result in significant added costs to consumers. This is due to increased development and home building time, caused by slow response time to project

timetables on the part of telephone and other utilities to L.M. Harris Company. Thus, the legal interests of L.M. Harris Company could be directly affected by the outcome of this proceeding.

3. The interests of justice and the orderly and prompt conduct of this proceeding will not be impaired by allowing L.M. Harris Company to intervene.

WHEREFORE, L.M. Harris Company respectfully requests that the Commission enter an Order granting L.M. Harris Company Petition to Intervene as a party in this docket, allowing L.M. Harris Company to participate to the full extent allowed by the rules of the Commission and by Utah Law.
