("AT&T") submits the following requests to Qwest Communications Corporation ("Qwest") to be answered by those officers, employees, or agents of Qwest (or its subsidiaries, affiliates or parent companies) who possess the requested information and who are authorized to answer on behalf of Qwest.

In responding to these requests, please refer to the definitions and instructions that were given with AT&T's First Data Request to Qwest.

DATA REQUESTS

1. For the following, please provide the service type counts, by CLLI code for the categories identified below. In Qwest's response AT&T seeks service counts related to *all* loops that are part of Qwest's outside plant regardless of tariffed service type (*i.e.*, regardless of whether the loop is Qwest retail service, private line, special access, Official Company Service, UNE, wholesale, *etc.*); when providing such service counts do not convert the count to copper-pair equivalents.

- a. Switched Basic Residential lines (all voice grade service lines including retail, UNE (all types including UNE-P) and resale and including lines with line shared DSL service) by wire center;
- b. Switched Basic Business lines (all voice grade service lines including retail, UNE (all types including UNE-P) and resale and including lines with line shared DSL service) by wire center;
- c. Business switched DS-0 lines by wire center;
- d. Switched business DS-1 lines (or equivalent -- HDSL) by wire center;
- e. Payphone lines by wire center;
- f. ISDN-PRI lines by wire center;
- g. ISDN-BRI lines (or equivalent IDSL) by wire center;
- h. Non-switched DS-0 or lower and analog voice grade lines;
- i. Non-switched UNE-L lines (including DSL lines that do not carry a switched voice channel except HDSL);
- j. Non-switched DS-1 lines (or equivalent -- HDSL);
- k. Non-switched DS-3 lines;
- l. PBX trunk;
- m. OCN (on an OC3 equivalent basis); and
- n. Other (with a basic service description).

If any of these line counts are counted in more than one category, please identify each line count and category.
