Dear Commissioners

On August 18, 2005, Qwest Corporation filed an Arbitrated Interconnection Agreement between Qwest Corporation and DIECA Communications Inc. dba Covad Communications Company that, upon filing, simultaneously terminated the prior interconnection agreement between the parties. The parties have agreed that certain amendments to the pre-existing interconnection agreement and other agreements would remain operative for their stated terms, or, if not specified, the life of the new interconnection agreement. Therefore, the parties now file the enclosed agreement entitled "Survival of Certain Agreements" that identifies the surviving agreements, for approval or informational purposes, as applicable.

Nothing herein shall be deemed as a waiver of Qwest's position that the QPP Agreement is not subject to the filing requirements of the federal Telecommunications Act, 47 U.S.C 252(e) or CLEC's position that it is subject to those requirements.

SURVIVAL OF CERTAIN AGREEMENTS

This Agreement regarding the Survival of Certain Agreements ("Agreement") is between DIECA Communications, Inc. d/b/a Covad Communications Company ("CLEC"), a Virginia corporation, and Qwest Corporation ("Qwest"), a Colorado corporation (collectively, the "Parties").

On October 28, 1999, the Utah Commission (the "Commission") approved an Interconnection Agreement between the Parties, for service in the State of Utah, as referenced in Docket No. 99-049-47 ("Pre-existing ICA").

The Parties have now executed a new Interconnection Agreement, which the Parties filed with the Commission for approval on August 18, 2005, in Arbitration Docket No. 04-2277-02 ("New ICA"). Upon approval by the Commission, the New ICA will replace the Parties' Pre-existing ICA.

The Parties concur that certain agreements (listed below) are to survive the termination of the Pre-existing ICA, and will continue to remain operative as set forth therein for their stated terms or, if not specified, for the life of the New ICA. These agreements were previously filed with and approved by the Commission.
