I, Rhonda Tounget, upon my oath state as follows:

1. I am a Manager of Network Expense at Level 3 Communications, LLC (“Level 3”), resident in its Broomfield, Colorado office. I make this affidavit in support of Level 3’s Motion for Entry of Order Consistent with Court’s Decision. I have direct personal knowledge of each of the facts stated herein, and if called upon to testify, I could and would do so truthfully.

2. On May 10, 2006, I caused the amount of \$833,980.65 to be paid by Level 3 to Qwest Corporation (“Qwest”) in satisfaction of the amount at issue in this matter, which amount represents \$563,616.99 in principle, plus \$270,363.66 in interest, as assessed by Qwest at 1.2%, running from the beginning date of the parties’ dispute (July 2, 2002) through May 10, 2006.

3. In order to refund Level 3’s payment as of the date set forth below, Qwest would have to pay Level 3 a total of \$1,005,930.71, which represents the principle amount paid to Qwest of \$833,980.65, plus \$171,950.06 in interest assessed at the rate of 1.2%, running from May 10, 2006 through August 31, 2007.

I declare that the foregoing is true and correct to the best of my knowledge.
