By The Commission:

On February 16, 2006, Covad Communications Company, Eschelon Telecom of Colorado, Inc., Integra Telecom of Utah, Inc., McLeodUSA Telecommunications Services, Inc., and XO Communications Services, Inc. (“Joint CLECs”) requested the Commission develop a list of non-impaired wire centers and a process for updating said list, enter a protective order and order compelling Qwest to provide certain wire center data to the Joint CLECs and the Division of Public Utilities, and, if necessary, open an investigative or other docket to address these issues.

On March 1, 2006, Qwest Corporation (“Qwest”) filed a Petition to Open a Commission Investigation and Adjudicatory Proceeding to Verify Qwest Wire Center Data and Resolve Related Issues, as well as a Motion for an Order Compelling the Production of CLEC-Specific Wire Center Data. Qwest agrees with Joint CLECs that a proceeding is necessary to implement the Federal Communications Commission’s (“FCC”) rulings in the Triennial Review Remand Order (“TRRO”) relating to unbundled dedicated transport and high-capacity loops, but differs from the Joint CLECs concerning the nature of the proceeding and the issues to be addressed. Qwest and the Joint CLECs also differ on the content of the requested protective order, method of identifying potentially confidential data, and the breadth of the order compelling Qwest to produce certain wire center data.

Therefore, **notice** is hereby given that a **procedural conference** in the above-entitled matter will be held with the Commission's Administrative Law Judge on **Thursday, March 9, 2006, at 1:30 p.m.**, Room 451, Heber M. Wells Office Building, 160 East 300 South, Salt Lake City, Utah. The purpose of this docket is to conduct an expedited adjudicatory proceeding to review and establish wire center line counts and numbers of fiber collocators per wire center necessary to implementation of the FCC's regulatory framework for unbundled dedicated transport and high-capacity loops set forth in the TRRO. The purpose of this procedural conference is to establish an expedited process and schedule for adjudication of these issues. In order to expedite proceedings, the Commission expects parties, prior to this procedural conference, to discuss and attempt to agree upon a proposed protective order and order compelling Qwest to produce certain wire center data.
