As a result of the proposed amended date for the Commission's Order to be issued, Manti also requests an extension of the stay that was granted in the Commission's Order on Rehearing dated February 15, 2013. In the Order on Rehearing, the Commission granted a stay of the Commission's December 28, 2012 Order for one hundred and twenty (120) days. The one hundred twenty day stay expires on June 15, 2013. Manti hereby requests that the stay be extended through June 28, 2013, to accommodate the newly proposed schedule and to give the Commission adequate time to consider the issues presented at the hearing.
