Because the Division of Public Utilities (Division) and Manti Telephone Company (Manti) continue to be engaged in settlement discussions, the Division moves the Public Service Commission to suspend the scheduling orders and the previously granted motion to extend in this case to allow additional time for the parties to reach a settlement (Motion). The Division requests that the schedule in this case be suspended until December 16, 2010, superseding the Division's previous motion filed on November 28, 2010, to suspend the schedule until December 5, 2010.<sup>1</sup> By December 16, 2010, the Division plans to file a completed stipulation, a motion to dismiss, a motion for an order to show cause, or any and
