At a settlement conference held on April 15, 2009 by the parties, the parties drafted a proposed scheduling order should the parties not be able to resolve their differences. The parties requested the Administrative Law Judge of the Commission to enter the settlement conference to calendar the following items and to ensure there were no conflicts. Attorneys appearing for the parties were as follows: 1) for Qwest: Alex Duarte, who appeared telephonically; 2) for Verizon, Tom Dixon and Richard Severy, who appeared telephonically, along with outside counsel Bill Evans, attending in person; 3) Michael Ginsberg, Assistant Attorney General, appeared for the Division of Public Utilities (Division), and attended in person; 4) for Sprint: Sharon Bertelsen, who appeared telephonically. Other company representatives of Qwest and Division staff were also in attendance.

Based on the agreements of the parties for the dates of the scheduling order, the Commission issues the following scheduling order:

1. Dates and deadlines as follows:

<b>Qwest files direct testimony</b>	Thursday, April 30, 2009
<b>Verizon files responsive testimony</b> <b>All other intervenors file responsive testimony</b>	Thursday, May 28, 2009
<b>The Division files testimony, if any</b> <b>Qwest responds to Verizon and other intervenors' testimony</b>	Thursday, June 18, 2009

2. The turn-around time on discovery shall be 10 calendar days. The parties, however, may mutually amend response times to times other than those provided here.

3. Notice is hereby given that a hearing in the above-entitled matter will be conducted by the Administrative Law Judge of the Public Service Commission of Utah on **Wednesday, July 8, 2009 at 9:30 a.m.**, Fourth Floor Hearing Room 451, Heber M. Wells State Office Building, 160 East 300 South, Salt Lake City, Utah.
