Dear Judge Arredondo:

As you will recall at the end of the above entitled hearing, there were numerous open issues related to the interconnection agreement between UBTA-UBET Communications, Inc. ("UBTA-UBET") and Bresnan Broadband of Utah, LLC ("Bresnan"). As you requested, since the hearing, UBTA-UBET and Bresnan have worked together to resolve as many of the open issues as possible. Through the diligent efforts of both parties, the parties have reduced the open issues considerably. There currently remain six (6) open issues for the Commission's review and consideration. These six open issues are outlined in the two documents filed herewith:

1) An Open Issues Matrix that identifies the six issues that remain open and disputed in the Interconnection Agreement between UBTA-UBET and Bresnan. The Open Issues Matrix sets forth, by Section Number, those portions of the Interconnection Agreement that the parties have not resolved, and which require arbitration of the Public Service Commission.

2) A draft of the Interconnection Agreement that identifies the "open paragraphs" in the agreement, with each party's proposed language side by side in the document.

The parties will submit briefs on the "open issues" on or before March 16, 2009, as previously ordered by the Commission.


