Bresnan Broadband of Utah, LLC (“Bresnan”), through its undersigned counsel, respectfully submits this Supplemental Status Report concerning the progress toward interconnection following the Commission’s Order in this docket.

1. The Commission, by its Order dated May 21, 2009 (“Interconnection Order”), directed Bresnan to provide a status report within one month after the entry of the

Interconnection Order, for the purpose of updating the Commission regarding the progress toward interconnection between Bresnan and UBTA-UBET Communications, Inc. (“UBET”).

2. On June 22, 2009, Bresnan filed a status report, indicating to the Commission that as of that time, it had presented for UBET’s execution two copies of an Essential Facilities Agreement (“Agreement”), in the form then-approved by the Commission, and that UBET’s Counsel indicated UBET did not intend to sign the Agreement in the form presented.

3. Following Petitions for Reconsideration, Review or Rehearing filed by both UBET and the Utah Rural Telecom Association (“URTA”), on August 3, 2009, the Commission issued its Order on Reconsideration, Review or Rehearing, wherein it affirmed its prior Interconnection Order, subject to one modification to Section 3.1.1 of the Agreement.

4. On August 4, 2009, Bresnan modified Section 3.1.1 as ordered, signed the Agreement in the final form approved by the Commission, and again presented two copies of the Agreement to UBET for execution.

5. On September 9, 2009, by Letter Agreement between Bresnan and UBET, the parties clarified their Interpretation and Application of Section 3.1.1 of the Interconnection Attachment to the Essential Facilities Agreement. A copy of the fully executed Letter Agreement is attached hereto as Attachment A.

6. With the Letter Agreement in place, UBET then signed the Essential Facilities Agreement on September 10, 2009. A copy of the fully executed Essential Facilities Agreement is attached hereto as Attachment B.
