The Public Service Commission of Utah ("Commission"), UBTA-UBET Communications, Inc. ("UBTA"), and the Utah Rural Telecom Association ("URTA") stipulate and agree as follows:

1. The acquisition of the Bresnan Communications, LLC's cable facilities in Vernal and Naples, Utah by UBTA's affiliate, Uintah Basin Electronics Telecommunications, rendered moot this appeal and the Commission's orders issued May 21, 2009 and August 3, 2009 in Commission Docket No. 08-2476-02 ("Commission Orders").

2. The Commission agrees to vacate the Commission Orders.

3. Based on the Commission's agreement to vacate the Commission Orders, UBTA and URTA agree to voluntarily move to dismiss this appeal pursuant to Rule 37(b) of the Utah Rules of Appellate Procedure.

4. UBTA and URTA's motion for voluntary dismissal is intended to supersede the Suggestion of Mootness, Motion to Vacate, and Motion to Dismiss UBTA and URTA filed in this appeal June 4, 2010.

5. By entering into this stipulation, no party waives any argument, made or not made, on any issue addressed in Commission Docket No. 08-2476-02.

6. By entering into this stipulation, the Commission does not waive its right to address any issue raised in Commission Docket No. 08-2476-02 in a future proceeding.
